WAGE DEDUCTION AUTHORIZATION

To: School District of Omaha

Pursuant to 79-12, 102 (Nebraska Statutes Revised), the undersigned teacher hereby authorizes and directs the Omaha Public Schools to withhold from wages to be paid the Annual Deductible Sum determined as provided herein. Annually, the Omaha Education Association, a professional organization of which the undersigned is a member, will certify to the Omaha Public Schools, the Annual Deductible Sum which shall be deducted from wage payments. The Annual Deductible Sum shall be deducted rateable from each payroll check issued by the Omaha Public Schools following receipt of certification of the Annual Deductible Sum for the contract year, provided however, any portion of the Annual Deductible Sum which remains unpaid shall be deducted from the last payroll check issued for the contract year. Enrollment in the unified profession shall be on a continuing basis. A member may resign her/his membership in writing on or before July 1st, for the following year. This authorization shall continue in force until a written notice of revocation is received by the Omaha Education Association. All amounts deducted shall be sent to the Omaha Education Association. I understand that the execution of this Wage Deduction Authorization is not required as a condition of membership in the Association.

This authorization shall permit and accept any changes in the amount of dues and/or contributions officially adopted by the respective governing bodies upon certification of the local association unless I revoke this membership in writing prior to July 1, 2009. I affirm that the above information is accurate to the best of my knowledge. I agree to remit to the Association, on an annual basis the total amount shown above.

EXPLANATIONS

¹ ETHNIC GROUP

Ethnic minority information is optional, and failure to provide it will in no way affect your membership status, rights or benefits in NEA, NSEA or any of their affiliates. The information will be kept confidential. This data is collected to ensure ethnic minority guarantees in the governance of the Association.

² DUES

NSEA is actively involved in financial support for recommended candidates for state and local office. NSEA's political action program is supported by voluntary contributions collected with the membership dues. This year's contribution is an amount to be determined* for full-time active members. Any NSEA member may request a refund of their contribution for the current membership year. Refunds are made after January 1 of each year, upon written request from an individual member. A refund notice will appear in the NSEA Voice. Annual membership dues to the NEA include an amount to be determined* for NEA Today. Of the total Nebraska dues an amount to be determined* is for a one-year subscription to NSEA Voice. Membership is open only to those who agree to subscribe to the goals and objectives of the Association and to abide by its constitution and bylaws. Membership dues are not deductible as charitable contributions but may be deductible under miscellaneous if you itemize deductions on your income tax form.

³ NEA-FCPE

The National Education Association Fund for Children and Public Education collects voluntary contributions from Association members and uses these contributions for political purposes, including, but not limited to, making contributions to and expenditures on behalf of friends of public education who are candidates for federal office. Contributions to The NEA Fund for Children and Public Education are voluntary; making a contribution is neither a condition of employment nor membership in the Association, and members have the right to refuse to contribute without suffering any reprisal. Although The NEA Fund for Children and Public Education requests an annual contribution of \$15, this is only a suggestion. A member may contribute more or less than the suggested amount, or may contribute nothing at all, without it affecting his or her membership status, rights, or benefits in NEA or any of its affiliates.

Contributions or gifts to The NEA Fund for Children and Public Education are not deductible as charitable contributions for federal income tax purposes.

Federal law requires us to use our best efforts to collect and report the name, mailing address, occupation and name of employer for each individual whose contributions aggregate in excess of \$200 in a calendar year.

Federal law prohibits The NEA Fund for Children and Public Education from receiving donations from persons other than members of NEA and its affiliates, and their immediate families. All donations from persons other than members of NEA and its affiliates, and their immediate families, will be returned forthwith.

⁴ OEA-CAF

The OEA Children's Action Fund for Children (OEA-CAF) collects voluntary contributions from OEA members and uses these contributions for political purposes, including, but not limited to, making contributions to and expenditures on behalf of candidates who are friends of public education. Contributions to OEA Children's Action Fund for Children are voluntary; making a contribution is neither a condition of employment nor membership in the Association, and members have the right to refuse to contribute without suffering any reprisal. The OEA Children's Action Fund for Children requires a payroll deduction minimum annual contribution of \$15. A member may contribute more than the minimum amount, or may contribute nothing at all, without it affecting his or her membership status, rights, or benefits in OEA/NSEA/NEA.

Contributions or gifts to OEA Children's Action Fund for Children are not deductible as charitable contributions for federal or state income tax purposes. OEA-CAF follows the guidelines set forth in The Nebraska Political Accountability and Disclosure Act (the NPADA) (§§49-1401 et seq, Nebraska Revised Statutes) which regulates the financial activities of state political action committees (PACs) in Nebraska.
